Therefore, for this particular case, we deem it proper to restrain the press and print media for reporting about the court proceedings or any matter connected with the investigation of this case."*

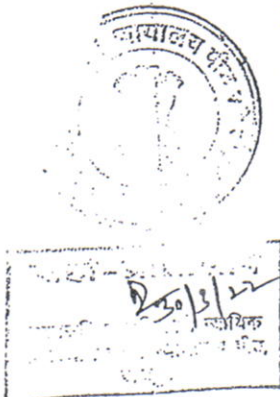
